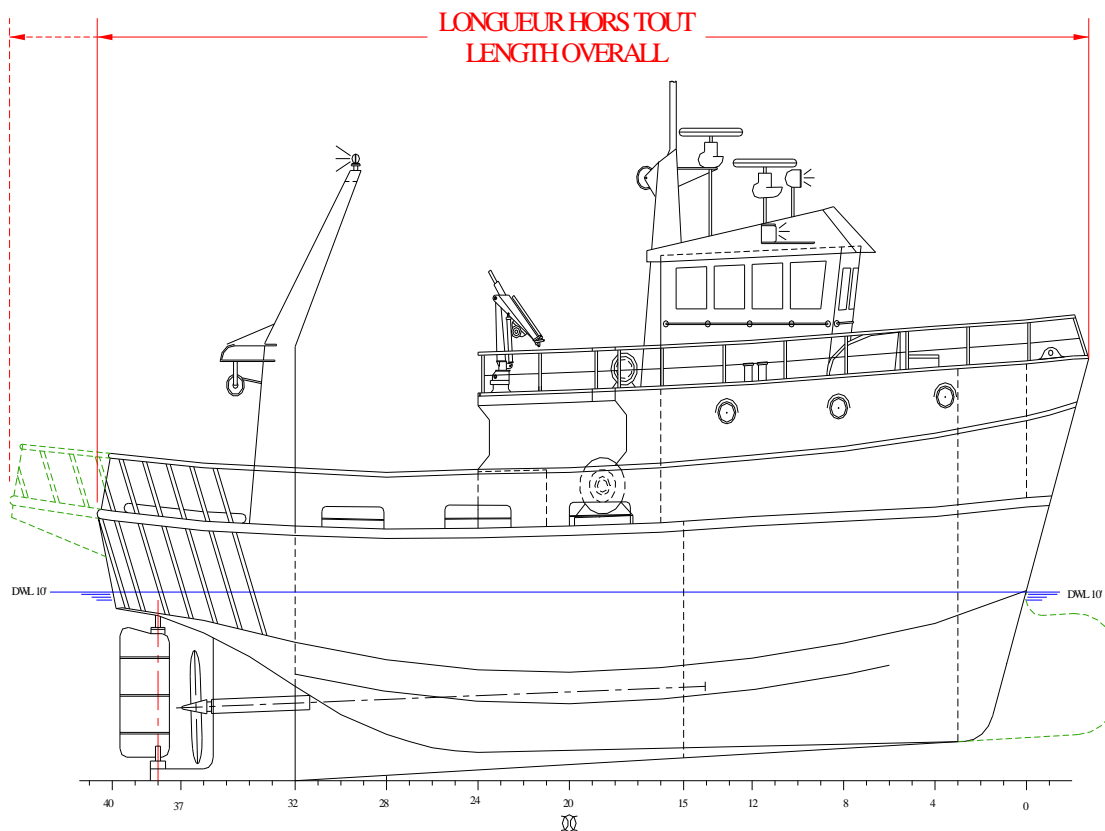

Length Overall

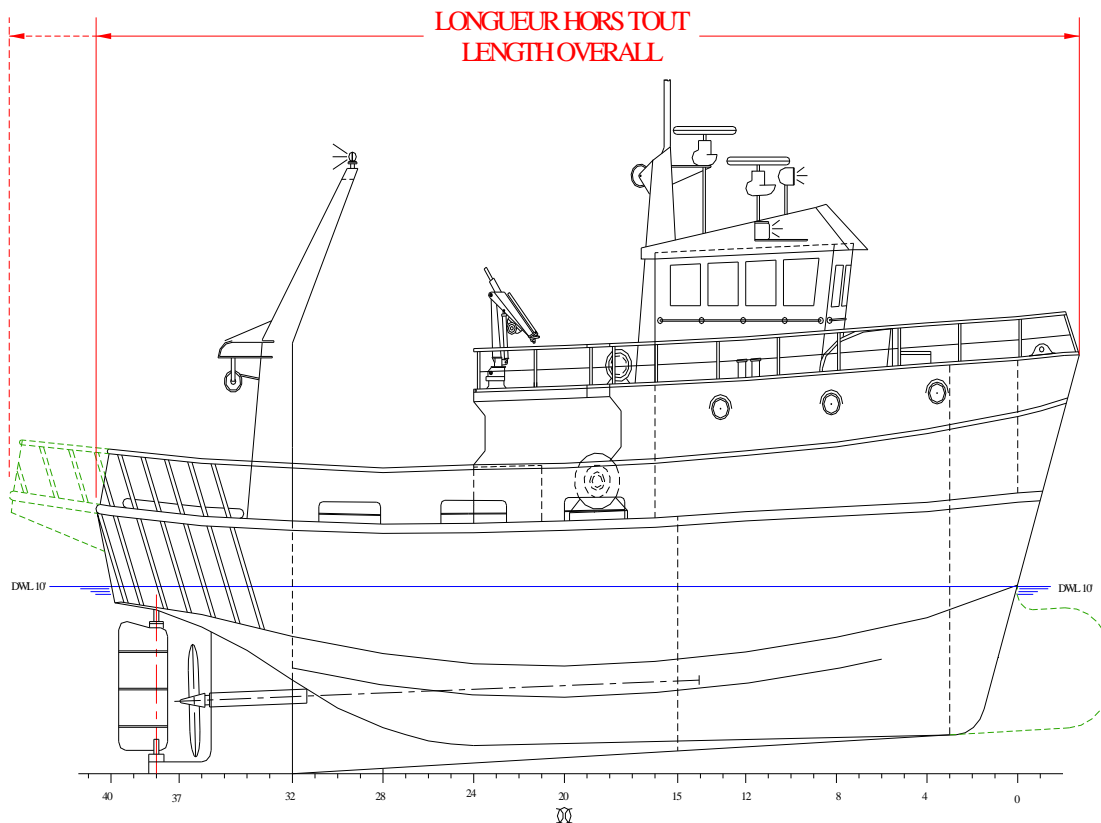
